1. Object of report

To advise the Partnership of the approved appointment of four new members and the reappointment of two current members.

2. Background

3. Current Position

Formal approval has now been received from the Cabinet Secretary for the above appointments. All appointments are effective from 1 April 2021 for a period of 4 years.

A short biography is attached at Appendix 1 for members information. For completeness, a summary of appointed members and appointment periods is also attached at Appendix 2.

An induction process has also been planned to ensure new members are given an insight into the work, responsibility and role of SPT. This will include sessions on the background of SPT; funding; Regional Transport Strategy; SPT's role in the bus market and delivery of bus services; and Subway background and modernisation.

These internal induction sessions will be supplemented with the normal externally facilitated sessions via "On Board" which covers Board member roles and responsibilities and members' roles in supporting equality and diversity in decision making.

All members are invited to attend all sessions, which will be held via video call. Site visits will be arranged once it is safe to do so.

Finally, attached at Appendix 3 is the updated Committee Composition which takes account as far as reasonably practical a balance of appointed and elected member representation, political and gender balance.

George Hazel

Dr Hazel has extensive experience in all aspects of transport and communications, both urban and rural. He has specific expertise from around the world in strategic planning and policy development, the integration of transport with other related areas, future trends for mobility and smart mobility and innovative funding of transport infrastructure.
